<u>1 Payment:</u> Due November 20th, 2024. <u>Includes:</u> Team shirt, Competition bow

#### NOT INCLUDED:

24/25 USASF Membership - Competition Uniform \$350 (same as 23/24 season) - Goodie Bags Warm-ups - Shoes - Crossover Entry Fees - Travel (e.g., hotel, food) - Post-Season Costs

### FINANCIAL TERMS & CONDITIONS:

- 1. All payments are non-refundable / non-transferable. Late fee of \$25 applies to any past due item.
- 2. Team Item Payments are not pro-rated for cases of illness, injury, sitting-out for late payment, or joining after Aug 2024.
- 3. Pay-in-full payments are discounted and therefore 100% non-refundable / non-transferable.
- 4. Returned check: \$30 fee & no personal checks accepted for remainder of the season.
- 5. Merchandise (e.g., uniform, clothing, etc) will not be distributed if ANY item (e.g., "tuition") is past due.
- 6. Service will be withheld (student sat-out) if payments become 30 days past due.
- 7. Early termination fee of \$350 will be assessed for quitting team between September 2024 April 2025.
- 8. Customers will approach staff and other families respectfully, and represent CheerForce positively in public (including social media). Failure to comply will be cause for removal from CheerForce with no refund of payments.
- 9. In the event an athlete is replaced in a competition, event entry fee is not refunded.
- 10. Any absence/injury within 14 days of competition (i.e., blackout period) may result in being replaced for that competition.

Financial Agreement disputes are adjudicated in California Small Claims Court.

CheerForce adds a minimum \$500 legal service fee if Small Claims Court adjudicates a dispute, regardless of outcome.
